Prevention

Aetiology

- e21** Elective delivery of twins at 37 weeks gestation decreases infant complications
- e22** Zinc supplementation for probable serious bacterial infection in early infancy may reduce the need for antibiotic change
- e23** Early planned birth may reduce neonatal sepsis compared to expectant management following preterm premature rupture of the membranes close to term
- e24** A brief intervention by emergency department providers decreased 12 month alcohol use
- e25** High-intensity interventions promote smoking cessation among hospitalized patients
- e26** Confirming the value of pulse oximetry screening for diagnosing critical congenital heart disease
- e27** Primary care-based screening, diagnosis and management of postpartum depression effective for improving symptoms
- e28** The cardiovascular risk of azithromycin was increased in a large observational cohort study, contradicting findings from prior randomised trials
- e29** Initiation of long-acting reversible contraceptive methods (IUDs and implant) at pregnancy termination reduces repeat abortion
- e30** Lack of association between proton pump inhibitors and adverse events in patients taking clopidogrel and aspirin
