

Therapeutics

- 167  Review: intensive glucose control reduced some CV events but did not change mortality in type 2 diabetes
- 168 Rosiglitazone was non-inferior to metformin plus sulphonylurea for CV events but increased risk of HF and fractures in type 2 diabetes
- 169 Minimally invasive and conventional glucose monitoring did not differ for long-term glycaemic control in insulin-treated diabetes
- 171 Once-only flexible sigmoidoscopy screening for colorectal cancer may not reduce colorectal cancer incidence or mortality
- 172 Review: aspirin reduces vascular events but increases bleeding in primary and secondary prevention
- 173 Review: aspirin does not reduce CV events but may reduce non-fatal stroke in peripheral artery disease
- 174 Paracetamol plus ibuprofen reduced fever in young children faster than paracetamol alone but not ibuprofen alone
- 175 Benefits of budesonide or nedocromil for mild to moderate asthma in children were not sustained after discontinuation
- 176 Review: exercise interventions reduce falls in elderly people living in the community
- 177 In patients with type 2 diabetes, perindopril-indapamide had similar relative reductions in mortality and cardiac events regardless of AF status

- 178 Both weight-bearing and non-weight-bearing exercise improved function in patients with knee osteoarthritis
- 179 Simulated acupuncture and real acupuncture both reduced low back pain dysfunction and symptoms
- 180 Review: evidence for the effectiveness of non-surgical interventions for low back pain and radiculopathy is limited
- 181 Review: evidence for the effectiveness of surgery for low back pain, radiculopathy, and spinal stenosis is limited
- 182 Review: erythropoiesis-stimulating agents increase mortality in patients with cancer

Diagnosis

- 183 The office-based blood agar plate culture was more sensitive than the rapid antigen detection test for detecting pharyngitis
- 184 Review: the Ottawa Ankle rules are accurate for excluding fractures in acute blunt ankle/midfoot injury in children

Prognosis

- 185 Site of psoriasis (scalp or intergluteal/perianal), ≥ 3 affected sites, and nail dystrophy predicted psoriatic arthritis in incident psoriasis

Clinical prediction guide

- 186 The Intermountain Risk Score, based on common laboratory tests, was highly predictive of short-term mortality
- 187 Review: 3 prediction rules, particularly ABCD, identify ED patients who can be discharged with low risk of stroke after TIA
