Telephone care was more effective than standard care for smoking cessation in daily smokers	137		
Combined budesonide and formoterol for maintenance and relief provided better asthma control than budesonide for maintenance and terbutaline for relief	138		
Addition of salmeterol to usual asthma pharmacotherapy may increase respiratory related deaths or life threatening experiences	139		
Review: vaccines prevent influenza and influenza-like illness in healthy children >2 years of age	140

Laparoscopic surgery was better than an intensive non-surgical intervention for weight loss in mild to moderate obesity	146

		Black cohosh and St John's wort reduced climacteric and depressive symptoms	148
		Calcium did not prevent fractures in elderly women	149
		Review: sparse evidence supports lifestyle modifications for reducing symptoms of gastro-oesophageal reflux disease	150
		Review: topical quinolones are better than systemic antibiotics for chronic suppurative otitis media at up to 2 weeks	151

		Response to a 2 week continuous positive airway pressure trial accurately identified patients with obstructive sleep apnoea syndrome	152
		Review: computed tomographic colonography is accurate for medium and large colorectal polyps and cancer	153
		Albumin to creatinine ratio in 2 random urine samples was an accurate screening test for albuminuria in diabetic pregnancies	154
		Review: magnetic resonance imaging alone is of limited usefulness in diagnosing multiple sclerosis	155
